



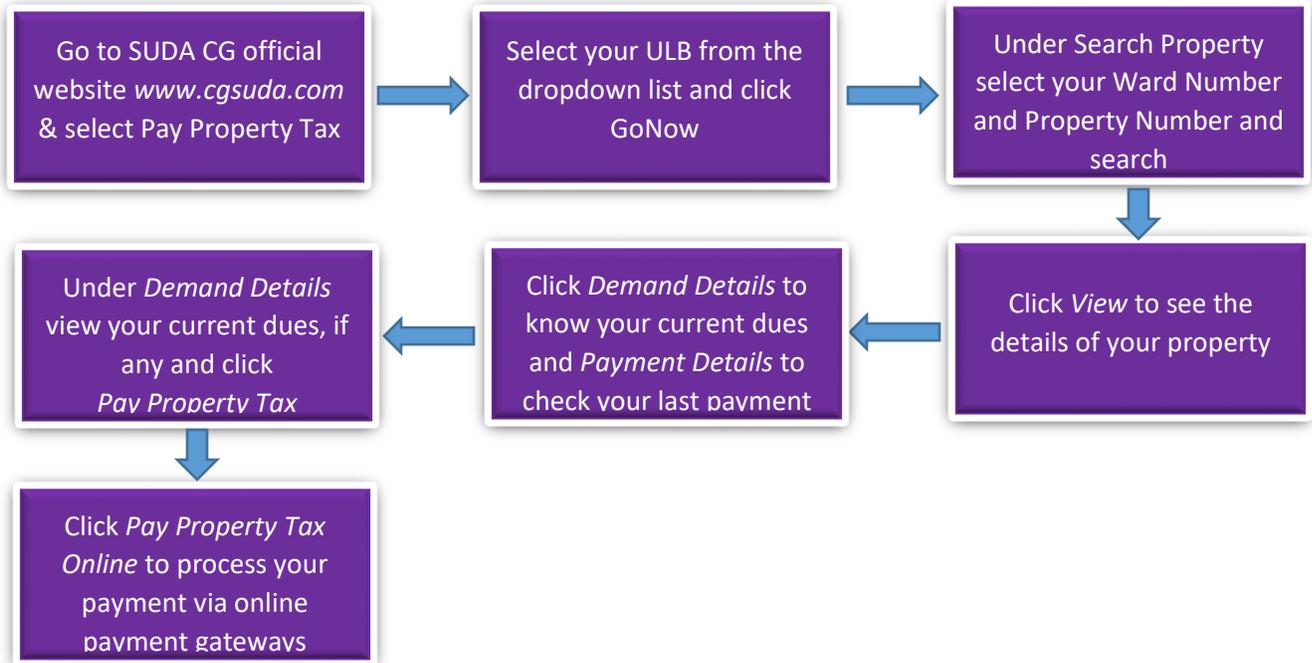

Flow



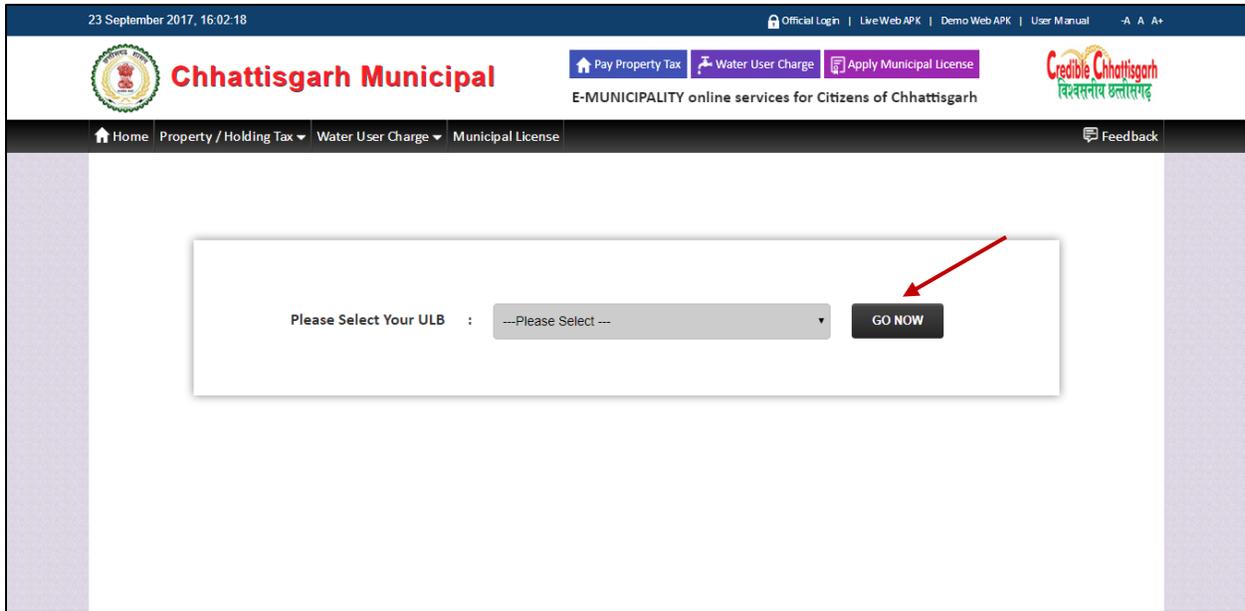
Detail Description

1. Go to SUDA CG official website www.cgsuda.com and select Pay Property Tax

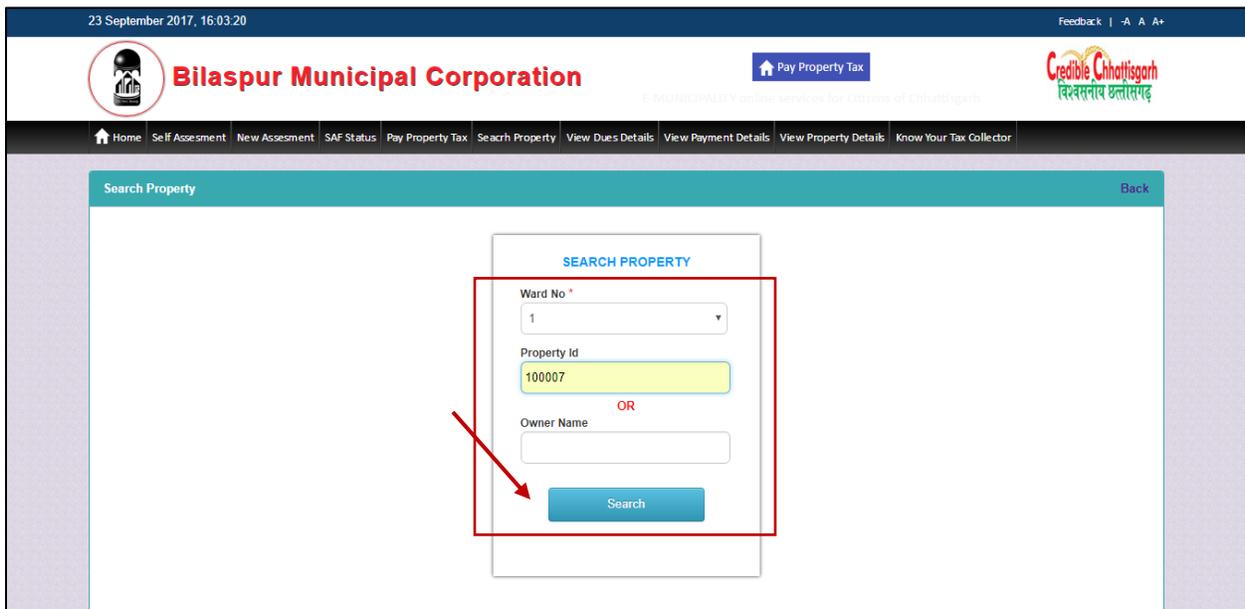
